FIG. 6 is a bottom (apex) view of the inventive ball and claw
bed boot design.

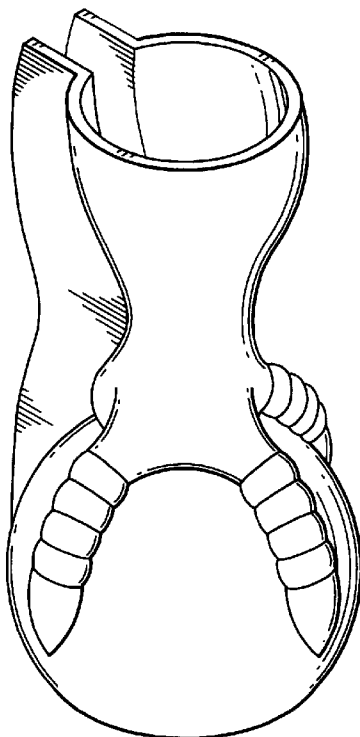

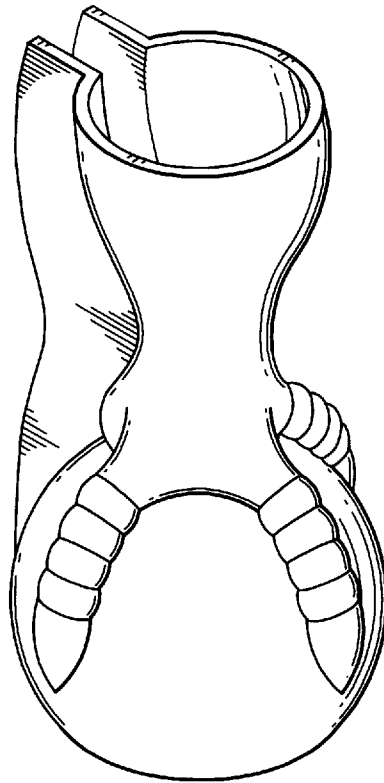

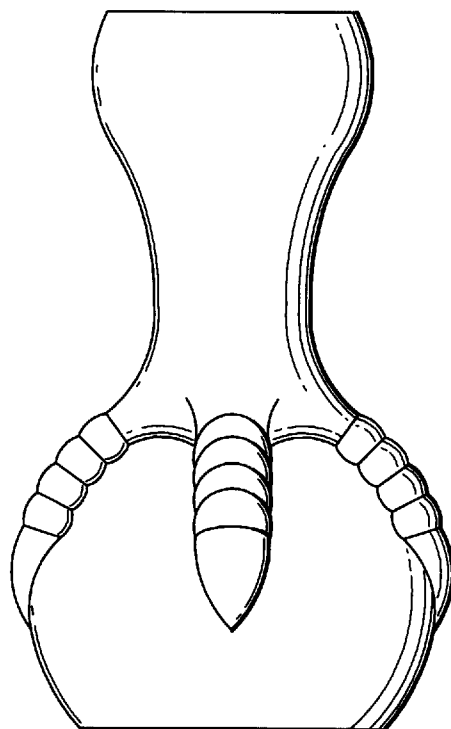

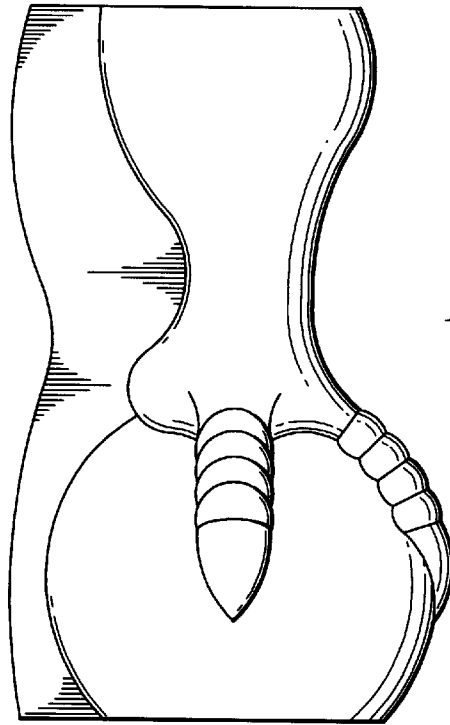

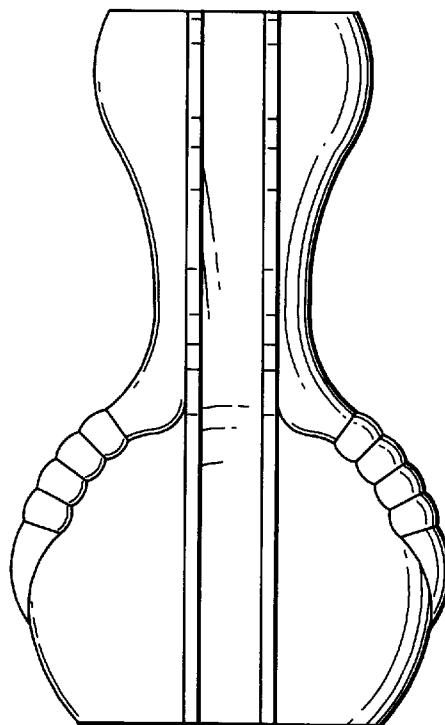

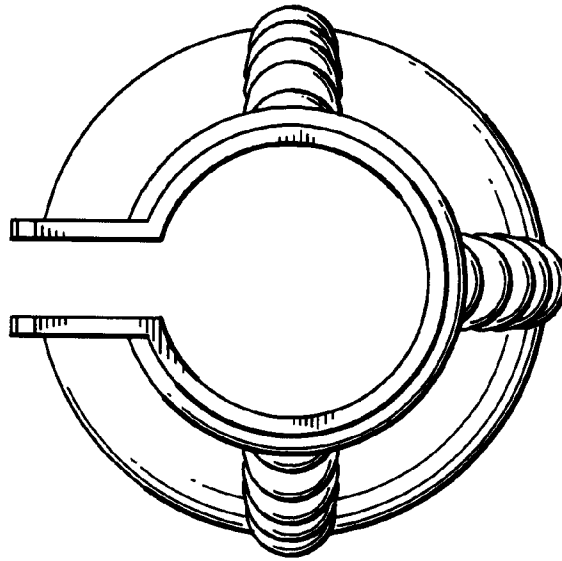

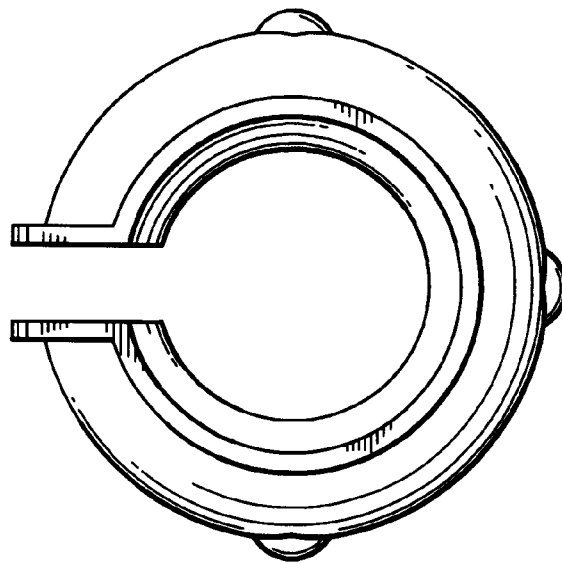
